### **Club By-laws**

1. The club will meet on the 3<sup>rd</sup> Thursday of each month in the guest room at the Elks Lodge #401 located at 2210 E Hickory Decatur, IL.
2. Members must be owner or co-owner of show-able vehicle, and must be willing to represent the club with a cheerful and positive attitude.
3. Members will include one household (single or married couple).
4. Club dues are \$10.00 per year. Members 55 or older may pay \$100.00 for a lifetime membership. All dues must be paid by December meeting.
5. Use of alcohol, drugs, loud music, reckless or careless driving, bad behavior, or abusive language will not be tolerated at any club function. Any club member who knowingly commits these acts, or slanders another club member, will be asked to leave the club immediately.
6. A flower bouquet and/or card will be sent to any club member who has knowingly been hospitalized regardless of length of stay. Cards will also be sent to club members who are sick at home. Please notify club of member's illness.
7. Officers of the club will be president, vice-president, secretary, treasurer, and event director. Candidates for these offices will be nominated in October and will be voted on in November. These officers will be elected for a 2(two) year period.
8. Eligibility to run for these offices, nominate or vote, requires at least 3 months of continuous membership. All voters must be in good standing with the club, and must have attended the 3 meetings prior to election.
9. The club treasurer will be accountable for all club expenditures. There will be no petty cash fund. The treasurer's records will be examined periodically. Checks for any purpose will require the signature of both the club president and the club treasurer. Checks in excess \$100.00, will need club approval.
10. Motions and requests at club meetings will be decided by a majority of the vote of those present.
11. Charitable donations will be limited to \$100.00/month for any purpose.
12. It will be the members responsibility to pay for their own meals and drinks at any club function unless it is a potluck. In that case, the club will provide meat, drinks and eating utensils only.
13. Benefit cruises can be for any person or persons, however, they can not replace a pre-scheduled event. Requests for benefit shows must be made to the club president and events director prior to the meeting. A separate cruise may be scheduled at a later date for that event.
14. Any changes, alterations, or amendments to these rules or by-laws will be decided by vote at club meeting and will need 80% majority of that vote.
15. Club equipment will not be loaned to anyone who is not a club member.
